



**Higher Education Emergency Relief Fund II (HEERF-II) – Policy and Application
for HEERF-II Student Aid Grants
Under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA)**

As part of the CRRSA Act enacted into U.S. law, the U.S. Department of Education (USDOE) has made emergency financial aid grants available to students whose lives have been disrupted by the COVID-19 pandemic. These disruptions have caused many individuals to face financial challenges to make ends meet. Students cannot apply for assistance directly from the U.S. Department of Education and must do so directly from their institution. Funds distributed to institutions are limited and based on formulas determined by the USDOE. Once exhausted, no other funds will be awarded. Peloton College is tasked with the responsibility of determining how grants will be distributed to students, how the amount of each student grant is calculated, and developing the process on how students can obtain the grant.

Determination of Grant Calculation and Distribution: Peloton College will calculate and distribute HEERF grant funds in a fair and equitable manner that will prioritize students with the greatest need. To do so, the school will consider the following for calculating and distributing funds:

1. A student is currently eligible to receive Federal Student Aid (FSA) or can demonstrate a need for financial assistance due to the COVID-19 pandemic.
2. Attest to expenses incurred due to disruption caused by the COVID-19 pandemic and your responsibility for related expenses. All eligible students who attest to financial need as outlined on this form will receive a HEERF-II grant up to a maximum of \$1,320. The HEERF grant amount will be prorated based on:
 - a. the proportion of FSA need determined by the Estimated Family Contribution (EFC) at the time of financial aid packaging when you enrolled at Peloton College or as determined through submission of a FAFSA to determine need (despite not receiving FSA monies). Contact your campus Financial Aid Office for guidance on submitting a FAFSA. Priority for distribution will begin with Pell Grant eligibility followed by FSA loan eligibility.
 - b. If your financial situation has changed due to the COVID-19 pandemic which caused a reduction in your income since you originally applied for financial aid or started school (for example, loss of employment or someone in your immediate household may have contracted COVID-19), you may request these circumstances be taken into consideration when determining the amount of your HEERF-II grant. Contact the Financial Aid Office to obtain and fill out an Independent Special Circumstances Request for Income Reduction form for consideration.
3. Students must be active at Peloton College as of March 13, 2020 or thereafter and be in good standing to be eligible to receive the grant. Individuals who start school (includes new or re-entered students) must be active for at least 30 days and attest that emergency financial need occurred after starting school and the need is a result of COVID-19 events.
4. Students who were actively enrolled as of March 13, 2020 or thereafter, were subsequently withdrawn from school and have since re-entered and are in good standing, may be eligible to apply. Those who were actively enrolled as of March 13, 2020 or thereafter, who were subsequently withdrawn and have not re-entered will not be eligible.
5. Fund Distribution for HEERF grant recipients:
 - a. funds will be distributed in a single disbursement within 14 days of the date the school receives the HEERF-II disbursement from the U.S. Department of Education.
 - b. where an individual will complete his/her program prior to the date set for grant distribution, a check for the full qualified amount will still be issued.
